MAJOR MUSEUM EXPANSION AHEAD

Historic Saranac Lake will Acquire the Trudeau Building at 118 Main Street

This spring, the Board of Directors made the decision to acquire the former home and medical office of Dr. E. L. Trudeau. Adjacent to the Saranac Laboratory and built the same year, the building is a natural location for museum expansion. We will take ownership of the building at the end of 2018 and begin restoration in the spring. The expanded museum campus will explore the history of Saranac Lake and Trudeau's pioneering work in tuberculosis treatment.

Since announcing the project this spring, we have received generous lead donations and

pledges totaling over \$300,000. The total project budget is \$1.7 million, which includes acquisition, major restoration, museum exhibits, and personnel. This summer, we submitted four major state grant applications, and we are one of the key projects in the village's \$10 million Downtown Revitalization Initiative. We also submitted an application for a \$250,000 National Endowment for the Humanities grant.

The project will provide improved museum collections storage space and a research room that will facilitate public access to our collection. Plans include the installation of interactive children's exhibits in both buildings, implementation of hands-on science activities in the laboratory space, expanded interpretation at the Saranac Laboratory Museum exploring important present day issues in public health and tuberculosis control and treatment. Rotating exhibits in the John Black Room at the Saranac Laboratory Museum will examine topics in local history beyond the theme of tuberculosis.

Our next John Black Room exhibit titled, "The Art of the Cure," will explore the rich history of occupational therapy in the development of

Saranac Lake's thriving arts community. The exhibit will feature arts and crafts created by TB patients such as artist Amy Jones, potter Mott Chapin, and the jewelry of Temmings Studio (pictured). The exhibit has won a grant from Humanities New York to support consultation on the exhibit script and design with museum consultant Caroline Welsh.

CURE PORCH ON WHEELS

We are thrilled to announce that the New York Council on the Arts Museum Program has awarded the Cure Porch on Wheels a grant of \$16,000 to support public programs in 2019. This is the second year of funding from NYSCA for this innovative project to bring arts and culture to the North Country. See page 5 for more information.

MUSEUM AND COLLECTIONS



SUMMER INTERNS

Rosemary Crowley and Sarah Dalton accomplished so much this summer, from greeting museum visitors to helping with organizing the collection. One of their undertakings was inventorying the surgical records of Dr. David Pecora, surgeon at Ray Brook State Hospital. Once completed, this database will help us answer reference requests and provide access to researchers. We are grateful to ongoing support from Kay and Marvin Best to the Ralph Kelly Education Fund.

IMLS GRANT COMPLETED

Museum Administrator Chessie Monks-Kelly has prepared a long-term preservation plan for our collections, made possible by a grant from the Institute for Museum and Library Services. Consultant Eileen Corcoran advised on the project, including updating her 2011 Preservation Assessment. The plan establishes steps to help us move forward with the collections for the next 3-5 years and onward. It also included an updated collections policy, posted on our website. Planning for enough appropriate collections storage and research space is a major component of the long-term preservation plan. The plan establishes guidelines for environmental controls, security, pest management, and other considerations as we move forward with the design and restoration of the building at 118 Main St.



NEW TO THE COLLECTION

Recent exciting additions to the collection include:

- A Saranac Lake Chiefs jersey.
- A collection of glass lantern slides related to TB sanatoria. These belonged to Julius Lane Wilson, who was a doctor in Saranac Lake in the 1920s.

NATIONAL REGISTER EXPANSION

Our project to expand the Berkeley Square National Register district is complete. The nomination has been submitted to the State Office of Historic Preservation, and we await their determination. If approved, the number of buildings listed on the National Register as part of the Berkeley Square Historic District will rise from 22 to 51 contributing buildings, making more properties on Main Street, Woodruff Street, Broadway, and Olive Street eligible for the historic preservation tax credit.
